Regular Meeting of The Council
Monday, October 28th, 2019

Town Council Present: Mayor Dick Claar, Councilmen Petersen, Smoot and Glenn

Town Council Absent: Councilman Owen Mathews

Town Employees/Representatives Present: Police Chief Doug Lundborg, Attorney Jim Peck, Public Works Director Cory Allison and HDR Engineer Heath Turbiville

Mayor Claar called the meeting to order at 7:00 pm and the Pledge of Allegiance was said.

Willard Gantz, town citizen, was present to discuss the curb/driveway at his house and the drainage issues he is having.

Char Delfino was present to request street closure for the Harvest Festival for the games prior to the Harvest Festival on November 9th from 11 am to 2 pm. The street would be closed from the area of Hopper's Driver through, straight across the street and down to the flag pole. **Councilman Glenn motioned to approve the street closure for the area and times of the event and Councilman Smoot seconded. Motion carried 4/0.**

Discussion was had on the Bill list. **Councilman Smoot motioned to approve the Consent Agenda, excluding Bill List 3 and Councilman Glenn seconded. Motion carried 4/0. Councilman Petersen motioned to approve Bill List 3 and Councilman Smoot seconded. Councilman Glenn abstained due to conflict of interest. Motion carried 3/0.**

Mayor Claar reported Clerk Schneider was out of town and she and the clerks were attending Caselle training in Casper for two days.

Chief Lundborg gave the police department report. He stated Officer Bill Peters retirement luncheon will be November 5th. He thanked Officer Peters for his work done for the town.

Nancy Feehan updated Council on the events at the MTC.

Cory Allison gave the public works department report. He reported Bob Gean donated two garage door openers to the Town. The Council publically thanked Mr. Gean for his donation.

Heath Turbiville updated the council on the projects in the Town. Discussion was had on the life span at the landfill. Mayor Claar stated he would like to see a workshop scheduled after the first of the year to further discuss the landfill.

Attorney Peck discussed the sale of the Town lots and Resolutions 8 and 9.
