Motion carried, 4/0.**

MTC-


Governor Gordon will be opening a select few businesses on May 1st, including gyms. Conversation was had about opening the MTC gym area back up.

Motion carried, 4/0.** Change Order # 2 is to install replacement 8" waterline with the pavement will be replaced by Owner. **Councilman Petersen motioned to approve Change Order #2 and being paid with 3rd Specific money, Councilman Glenn 2nd. Motion carried 4/0.**

There was inquiry about replacing the sign at Robinson Park. Councilmen visited about requested getting a cost first.
