Regular Meeting of the Council
Monday, June 8th, 2020

Town Council Present: Mayor Dick Claar, Councilmen Paul Smoot, Ben Glenn and Dale Petersen

Absent: Councilman Owen Mathews

Town Representatives Present: Clerk/Treasurer Cheryl Schneider, Attorney Pat Carpenter, HDR Engineer Heath Turbiville

Mayor Dick Claar called the meeting to order at 7:00 pm with the Pledge of Allegiance being said.

Cy Stewart was present to request permission to sell cars online within the Town limits. The cars will be located outside of Town limits. He is requesting a letter from the Town stating there are no restrictions for him to do so. **Councilman Glenn motioned to allow Cy Stewart to sell cars from his residence and Councilman Smoot seconded. Discussion was had on where the vehicles would be stored. Councilman Glenn amended his motion to include not storing the vehicles for sell at his residence in the town limits and Councilman Smoot amended his second. Motion carried 4/0.**

Neal Gray, Moorcroft Chamber representative, was present to discuss the upcoming Jubilee and to ask for permission to hold it on Saturday, July 11th only. **Councilman Petersen motioned to allow Jubilee on Saturday, July 11th and Councilman Glenn seconded. Motion carried 4/0.** Neal Gray requested to relax open container on Saturday, July 11th. **Councilman Smoot motioned to allow open container from 12:00 noon until midnight on Saturday, July 11th from S. Big Horn, Converse to Railroad, alley to alley and Councilman Glenn seconded. Motion carried 4/0.** Neal Gray requested the Chamber of Commerce be allowed malt beverages at a beer garden during Jubilee. Discussion was had. The decision will be tabled until Pat Carpenter receives further information on the request.

Dee Gray, Crook County Senior Citizens, was present to discuss the upcoming mil levy that will be on the ballot.

Councilman Petersen motioned to approve the Consent Agenda and Councilman Glenn seconded. Motion carried 4/0.

Clerk Schneider gave the clerk's report. She stated the final approval for the feasibility study is at SLIB. The meeting is scheduled for June 16th. Clerk Schneider requested authorizing Chief Bill Bryant to the Visa. **Councilman Smoot motioned to approve the request to add Chief Bill Bryant to the Visa and Councilman Glenn seconded. Motion carried 4/0.** Clerk Schneider stated LeAnn Kerzman, Midwest Assistance, reached out and is now the regional area field manager. Their company provides many free services including water, landfill and various other trainings.

Dan Blakeman, Moorcroft Town Center representative, was present to discuss the Council's objectives for the committee. Nancy Feehan updated the Council with MTC upcoming events.

Heath Turbiville updated the Council on the Town's projects. He discussed the Certificate of Completion on the Powder River Water Phase I. **Councilman Glenn motioned to accept the certificate of completion and Councilman Petersen seconded. Motion carried 4/0.**

Two Ordinances were presented for readings.

Ordinance 1-2020 - 3RD Reading

ORDINANCE 1-2020, TITLE 12, CHAPTER 5, SECTION 12-501; AN ORDINANCE AMENDING TITLE 12 OF THE CODE OF THE TOWN OF MOORCROFT, WYOMING 1979, TO INCLUDE AS CHAPTER 5, SECTION 12-501 AND ORDINANCE PROHIBITING THE USE OF ENGINE COMPRESSION BRAKES; PROVIDING A PENALTY FOR VIOLATION; AND PROVIDING FOR AN EFFECTIVE DATE.

Councilman Petersen motioned to approve Ordinance 1-2020 on 3rd reading and Councilman Smoot seconded. Motion carried 4/0.

Ordinance 2-2020 – 1st Reading

ORDINANCE 2-2020 , AN ORDINANCE APPROPRIATING MONEY FOR THE 12 MONTH PERIOD BEGINNING JULY 1, 2020 AND ENDING JUNE 30, 2021.

Councilman Glenn motioned to approve Ordinance 2-2020 on 1st reading and Councilman Petersen seconded. Motion carried 4/0.

Mayor Claar stated there will be a special meeting on June 15th for the 2nd reading of Ordinance 2-2020. The meeting will start at 4:00 pm.

With no further business, **Councilman Petersen** motioned to adjourn the meeting at 8:10 pm and **Councilman Smoot** seconded. Motion carried 4/0.
