ORDINANCE NO. 2-2022

TITLE 1, CHAPTER 3, SECTION 1-316

ORDINANCE AMENDING SECTION 1-316 (b) OF CHAPTER 3, TITLE 1 OF THE CODE OF THE TOWN OF MOORCROFT, WYOMING 1979 TO PROVIDE THE DISCRETIONARY FORMATION OF THE MOORCROFT TOWN CENTER:

BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF MOORCROFT, CROOK COUNTY, WYOMING that:

SECTION 1: Section 1-316 (b) of Chapter 3, Title 1 of the Code of the Town of Moorcroft, Wyoming, 1979 shall be and the same hereby is amended to read in complete form as follows:

"1-316 COMMITTEE APPOINTMENTS AND COMMITTEES –

Standing Committees of the Town are: Finance and Personnel; Streets, Alleys and Buildings; Water and Wastewater; Sanitation and Landfill; Police and Emergency Services; Parks, Recreation and Cemetery. Committees shall consist of two (2) Councilmembers appointed by the Mayor annually in January at a regular or special meeting, and each Councilmember shall serve on at least two (2) Standing Committees and continue to serve on such Standing Committees until his/her successor is appointed. The Mayor shall be an ex officio member of each Standing Committee. If the office of a Councilmember should become vacant, the person appointed to fill such vacancy shall serve on the same Standing Committees on which the vacating Councilmember served. In addition to such functions as may be provided in this Code, the purpose of each Standing Committee is to look into and make recommendations regarding issues involving the operations of the Town in the area for which the Standing Committee is appointed. In addition to Standing Committees, the Governing Body may authorize the creation of Select Committees, which may consist of Councilmembers and/or others, the purpose for which is to look into and make recommendations regarding specific limited matters. The members of a Select Committee shall be

appointed by the Mayor, and such appointment shall expire on the completion of the object or purpose for which the Select Committee was created and authorized."

(b) There may be a special committee known as the Moorcroft Town Center Committee. If formed or continued by the Town Council, the Committee shall consist of members whose number, term and qualification shall be established by the Town Council by Resolution. If appointed, Committee members shall serve without compensation. If formed or continued, Committee members shall be appointed by the Mayor with consent of the Council, and may be removed by the Mayor and Council with or without cause. The Moorcroft Town Center Committee may be formed or disbanded at any time by resolution of the Town Council.

SECTION 2: This Ordinance shall become effective after passage and upon publication as provided by law, and all ordinances or parts thereof in conflict herewith are repealed to the extent of such conflict.
