

## REGULAR COUNCIL MEETING

Monday, November 13, 2012

Mayor Steve Blakeman called the Regular Council Meeting to order on Monday, November 13, 2012 at 7:00 PM. Council members present were Jim Rexford, Fred Devish, Dale Petersen, and Ben Glenn. Visitors present were Gordon Spiedel, Brian Black, Denise Karen, Vicki Paddock, Jim Reeves, Thaen Reeves, Councilman elect Owen Mathews, and Grace Moore.

Gordon Spiedel requested permission for the Town to help make the handicap parking spot at the Bethlehem Lutheran Church an actual spot. The Town maintenance workers will paint the markings and a sign will be put up.

Brian Black representing The Hub Cafe asked that the Council and Mayor reconsider the price of the bar and grill liquor license.

November Bill List 1 was pulled from the consent agenda. Councilman Devish motioned to approve the consent agenda Glenn 2<sup>nd</sup> all ayes, motion carried. November Bill List 2 was added to the consent agenda. Councilman Rexford abstained Glenn made the motion to approve November Bill List 2 Devish 2<sup>nd</sup> all ayes, motion carried. A bill to Pinnacle Bank was added to November Bill List 1 in the amount of \$56,273.99. Councilman Devish motioned to approve November Bill List 1 with the addition Rexford 2<sup>nd</sup> all ayes, motion carried.

Clerk Candace Nelson gave her report.

Chief Ed Robinson gave his report. Chief Robinson asked for permission for the Mayor to sign the Homeland Security Grant to move forward with this process. Dale motioned for the Mayor to sign the grant information Rexford 2<sup>nd</sup> all ayes, motion carried.

Bill Carson of HDR Engineering gave his report. On December 6, 2012 there is a SLIB meeting Bill encouraged the Mayor to attend in Cheyenne.

Administrator Dan Blakeman gave his report. The Town was awarded the TEAL Grant. Blakeman asked for permission to hire Amanda Bugenhagen at \$11.00 an hour as the Deputy Clerk. Glenn motioned to hire Amanda Bugenhagen at \$11.00 an hour Rexford 2<sup>nd</sup> Glenn, Devish, and Rexford aye, Petersen nay motion carried.

Fire Chief Devish asked for a consensus of the Council for a generator at the Public Safety Building.
