

## **REGULAR COUNCIL MEETING**

September 23, 2013

Mayor Steve Blakeman called the Regular Council Meeting to order at 7:00 PM on Monday, September 23, 2013. Council members Owen Mathews, Fred Devish, Dale Petersen, and Ben Glenn were present. Visitors present were Gari Gill, Ruth Smith, and Grace Moore. Seniors present were Tyler Jones, Colton Richter, William West, and Emily VerBurg.

Gari Gill discussed the Crook County Multi-Hazard Mitigation Plan. Mr. Gill asked that the Town adopt the plan by Resolution. Mayor Blakeman signed Resolution No. 7 Adopting the Crook County Multi-Hazard Mitigation Plan.

Councilman Petersen motioned to approve the September 9, 2013 regular council meeting minutes, September 10, 2013 special council meeting minutes and the executive session minutes also from September 10, 2013 Mathews 2<sup>nd</sup> all ayes, motion carried. From bill list 3 Councilman Petersen discussed the Schutz Foss bill. Devish motioned to approve bill list 3 Mathews 2<sup>nd</sup> all ayes, motion carried. Petersen motioned to approve bill list 4 Mathews 2<sup>nd</sup> Devish, Mathews, Petersen aye, Glenn and Blakeman abstained motion carried.

Clerk Nelson gave her report. Nelson asked for the approval of the Town to pay for staff's flu shots. Glenn motioned to pay for Town Employee's shots Mathew 2<sup>nd</sup> all ayes, motion carried.

Police Chief Ed Robinson gave his report and provided a written staff report.

Heath Turbiville with HDR Engineering gave an update. Discussion was held on how the Town is going to move forward with the S. Belle Fourche project. Discussion was held on S. Little Horn project.

Administrator Dan Blakeman gave his report. The regional landfill meeting will be held on October 17, 2013 at the Public Safety Building at 1:00 PM. Councilman Mathews motioned to approve the use of the Town property for staging area contingent upon it not interfering with the Little Horn project and gave permission for a temporary walk way for students to use during the construction phase Devish 2<sup>nd</sup> all ayes, motion carried. Blakeman provided the insurance policies for the Town HUB amount was \$15,111.00 and Security Insurance amount was \$26,769.00. Mathews motioned to go with HUB Insurance for all coverage Glenn 2<sup>nd</sup> all ayes, motion carried. Final changes and additions were made to mobile home ordinance it will be sent back to Attorney Jim Peck and first reading will be held October 14, 2013.

Mayor Blakeman would like to have the Public Hearing for the selling of Town lots at the next meeting. Discussion was held on finishing some more blocks at the Westview Park. Councilman Petersen will ask the High School student council to help.

Petersen motioned to go into executive session for personnel at 8:59 PM Mathews 2<sup>nd</sup> all ayes, motion carried. The Mayor and Council came out of executive session at 9:27 PM with no decisions made the meeting was adjourned at 9:27 PM.
