**TITLE 1, CHAPTER 3, SECTION 1-316**

**ORDINANCE AMENDING SECTION 1-316 OF CHAPTER 3, TITLE 1 OF THE CODE OF THE TOWN OF MOORCROFT, WYOMING 1979 TO INCLUDE AS SUBSECTION (b) PROVISIONS TO ESTABLISH A SPECIAL COMMITTEE TO OVERSEE THE MOORCROFT TOWN CENTER; PROVIDE FOR THE APPOINTMENT OF MEMBERS; PRESCRIBE RESPONSIBILITIES; AND PROVIDE FOR AN EFFECTIVE DATE.**

**BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF MOORCROFT, CROOK COUNTY, WYOMING that:**

**SECTION 1:** Section 1-316 of Chapter 3, Title 1 of the Code of the Town of Moorcroft, Wyoming, 1979 shall be and the same hereby is amended to read in complete form as follows:

“1-316 COMMITTEE APPOINTMENTS AND COMMITTEES –

- (a) Standing Committees of the Town are: Finance and Personnel; Streets, Alleys and Buildings; Water and Wastewater; Sanitation and Landfill; Police and Emergency Services; Parks, Recreation and Cemetery. Standing Committees shall consist of two (2) Councilmembers appointed by the Mayor annually in January at a regular or special meeting, and each Councilmember shall serve on at least two (2) Standing Committees and continue to serve on such Standing Committees until his/her successor is appointed. The Mayor shall be an ex officio member of each Standing Committee. If the office of a Councilmember should become vacant, the person appointed to fill such vacancy shall serve on the same Standing Committees on which the vacating Councilmember served. In addition to such functions as may be provided in this Code, the purpose of each Standing Committee is to look into and make recommendations regarding issues involving the operations of the Town in the area for which the Standing Committee is appointed. In addition to Standing Committees, the Governing Body may authorize the creation of Select Committees, which may consist of Councilmembers and/or others, the

purpose for which is to look into and make recommendations regarding specific limited matters. The members of a Select Committee shall be appointed by the Mayor, and such appointment shall expire on the completion of the object or purpose for which the Select Committee was created and authorized.”

- (b) There shall be a special committee to be known as the Moorcroft Town Center Committee. The Committee shall consist of seven (7) members, each serving a two (2) year term. Of the initial committee members, the terms of three (3) members shall expire in January, 2019, and the terms of four (4) members shall expire in January, 2021. Thereafter, each member shall serve a two (2) year term, or until their successor is appointed. At least a majority of the committee members must be residents and registered voters of the Town, and the remainder of the Committee members must be residents and registered voters of Crook County, Wyoming, and remain residents and registered voters of Crook County during their term in office. Committee members shall serve without compensation. Committee members shall be appointed by the Mayor with consent of the Council, and may be removed by the Mayor and Council for good cause. Upon initial appointment, the committee shall elect a chairperson who shall serve until January, 2019, then annually thereafter the committee shall elect a chairperson. Subject to review and oversight by the Mayor and Council, the committee shall have general authority over the Moorcroft Town Center facility.


