TITLE 13, CHAPTER 3, SECTION 13-304-15

ORDINANCE AMENDING SECTION 13-304-15 OF CHAPTER 3, TITLE 13 OF THE CODE OF THE TOWN OF MOORCROFT, WYOMING, 1979, TO PROHIBIT OPEN FIRES; PROVIDING EXCEPTIONS; AND ESTABLISHING AN EFFECTIVE DATE.

BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF MOORCROFT, CROOK COUNTY, WYOMING, that:

SECTION 1: Section 13-304-15 of Chapter 3 of Title 13 of the Code of the Town of Moorcroft, Wyoming, 1979, shall be and hereby is amended to provide in complete form as follows:

“13-304-15 – OPEN FIRES PROHIBITED; EXCEPTIONS-

- (a) It shall be unlawful for any person to start or ignite, or cause to be started or ignited, any fire within the Town outside of a home, garage, shop or other enclosed building, except: (i) a fire in a barbeque or smoker used for cooking food (gas, charcoal or otherwise); or (ii) a recreational fire as defined in subsection (b) below.
- (b) The term “recreational fire” as used in subsection (a) above shall mean a small controlled fire contained in either a free-standing nonflammable fire box or container or in a nonflammable enclosure on or in the ground, which does not exceed ten square feet in size. Except when igniting the fire, only wood or commercial fireplace logs shall be burned, which shall be of such size so as to fit completely within the fire box, fire container or fire enclosure. Except when tending the fire, the fire shall at all times be enclosed by nonflammable materials to prevent the fire from burning outside of the fire box, fire container or fire enclosure, and to prevent sparks from the fire from becoming airborne. At all times the fire shall be attended by a person sixteen years of age or older.”


SECTION 2: This Ordinance shall become effective after passage and upon publication as provided by law.

Passed on second reading: September 26, 2011


