CHAPTER 3 – PARKING 12-301 – Parking and Street use Restriction Penalty

## 12-301 - PARKING AND STREET USE RESTRICTIONS; PENALTY -

The following parking restrictions are in addition to the provisions of Wyoming Statutes Sections 31-5-501 through 31-5-512 of the Uniform Act Regulating Traffic On Highways as adopted by the Town in Section 12-101 of this Code.

For the purposes of this Section, "recreational vehicle" means a motorized vehicle, or a non-motorized vehicle which can be driven or towed by a motorized vehicle, which is primarily designed for temporary living accommodations for recreational, camping and/or travel use including, but not limited to, motorized motorhomes, motorized camping vans, camp/travel trailers, pop-up camp trailers, and slide-in pick-up box campers (but not pick-up box toppers).

It shall be unlawful for any person to park, leave, place or let stand on any public highway, street or alley within the Town or on any municipal Town parking area any vehicle which is not currently licensed to be operated or towed on public highways or which is inoperable, or which cannot be safely operated or towed.

It shall be unlawful for any person to park, leave, place or let stand on any public highway, street or alley within the Town or on any municipal Town parking area any equipment, machinery, materials, supplies, excavated material, items or other things, excluding vehicles; except and unless in connection with an ongoing construction project on property adjoining the public highway, street or alley at such location or within the parking area, and only to the extent permitted by the Town Police Department.

It shall be unlawful for any person to park, place or let stand any vehicle on any public highway, street or alley within the Town abutting the lot or tract of land upon which is located a residential dwelling without the permission of one or more of the owners or renters of the residential dwelling. "Residential dwelling" means a building designed and used primarily for residential occupancy with one dwelling unit or two separate dwelling units, including mobile homes, but does not include multiple unit residential dwellings with three or more dwelling

units.

It shall be unlawful for any person to connect any electric cord or line, or water hose or line, from any residential or business premise to any recreational vehicle which is parked on any public highway, street or alley within the Town for more than seven (7) days within any thirty (30) day period. It shall be unlawful for any person to connect any electric cord or line, or any water hose or line, from any residential or business premise to any recreational vehicle which is parked on any public highway, street or alley within the Town for any period of time if the electric cord or line, or water hose or line, does not lie flat on the surface of the ground, sidewalk or other surface of the public property on which it lies so that the electric cord or line, or water hose or line, does not constitute a tripping hazard to pedestrians.

It shall be unlawful for any person to park, leave, place or let stand on any public highway, street or alley within the Town any vehicle if any part of the vehicle extends onto or over any public sidewalk or onto or over the travel lane of the public highway, street or alley.

Violation of this section shall be punishable by a fine of up to Three hundred dollars (\$ 300.00)
